

The Department of Political Science is seeking qualified instructors for the following 3 courses for the Winter Term:

POLI 204 *Introduction to Canadian Politics* (3 credits)

This course is a basic introduction to the fundamental issues of Canadian public life and the federal political system. It presents an overview of the constitution, institutions, political parties, electoral system, interest groups, and public opinion that represent the essential components of Canada's political culture and government.

Requirements: Applicants must have:

- a Ph.D., or be near completion of a doctoral degree, in Political Science specializing in Canadian and Quebec Politics; or
- extensive teaching experience in Political Science specializing in Canadian and Quebec Politics at the university level.

New applicants to the department should also include:

- a cover letter describing their qualifications for the courses for which they are applying,
- a copy of their C.V., and
- two letters of recommendation.

Applications by existing members for courses that they have not previously taught more than three times should also include:

- cover letters describing their qualifications for each of the classes they are applying for.

POLI 334 *Political Participation in Canada* (3 credits)

Prerequisite: POLI 204 or permission of the Department. This course examines the various approaches to understanding the participation of the public in politics, primarily electoral but also non-electoral activities, in Canada and from a comparative perspective.

NOTE: Students who have received credit for this topic under a POLI 398 number may not take this course for credit.

Requirements: Applicants must have

- a Ph.D., or be near completion of a doctoral degree, in Political Science specializing in Canadian and Quebec Politics; or

POLI 361 *Advocacy Groups and Public Policy* (3 credits)

Students examine the broad social, economic, political, and cultural forces shaping governmental decisions and policies. Particular attention is paid to the conflict between private and public concerns.

Requirements: Applicants must have

- a Ph.D., or be near completion of a doctoral degree, in Political Science specializing in Canadian Politics or Public Policy and Administration; or
- extensive teaching experience in Political Science specializing in Canadian Politics or Public Policy and Administration at the university level.

New applicants to the department should also include:

- a cover letter describing their qualifications for the courses for which they are applying,
- a copy of their C.V., and
- two letters of recommendation.

Applications by existing members for courses that they have not previously taught more than three times should also include:
